Candidates should be interested in translational research and the development of new therapies to cure blindness or other diseases. The PhD scholar will have a direct impact on lab development and its success in publishing in high impact factor journals. The person will be also responsible for performing dynamic research to create a competitive research group. The position will be assigned to Optical Imaging Group led by Prof. Maciej Wojtkowski, focused on developing new imaging techniques aiming at achieving speckle-less imaging based on full-field swept-source optical coherence tomography, for diagnosis, screening and monitoring of blinding eye diseases.</p>
